Eligibility:

- 1. Employee of a Region 1 VPPPA member company, or a spouse, child, or grandchild of an employee of a Region 1 VPPPA member company.
- 2. Be a full-time student entering the second or sophomore year of college or beyond in 2025.
- 3. Be a full-time student majoring in an Occupational Safety or Occupational Health field.

<u>Academic Requirements:</u>

The student must have a grade point average of \geq 3.0 out of a 4.0 at the time of application. There is no limit on the number of years one student can receive funds.

Request for Funds:

A student may apply after the first marking period in the freshman year. The Scholarship Committee may request subsequent academic records as deemed necessary.

- Deadline for application is March 30, 2025.
- Final \$1000 award decision is rendered by the Scholarship Award committee.
- Decision will be announced to applicants by May 6, 2025, during our Annual Conference & Exhibition.
